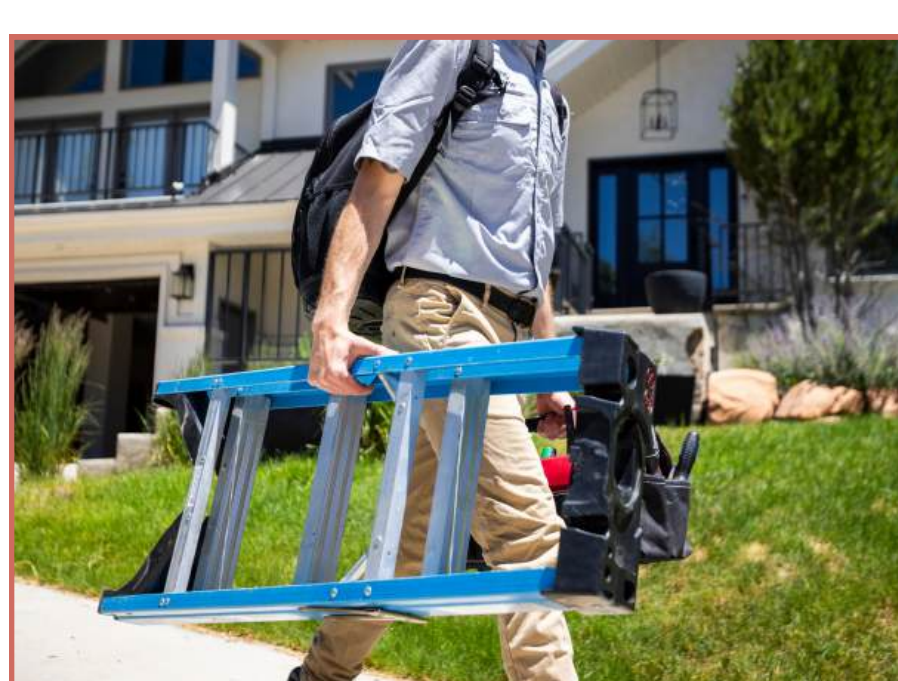
2. Why This Matters for Arizona Homeowners

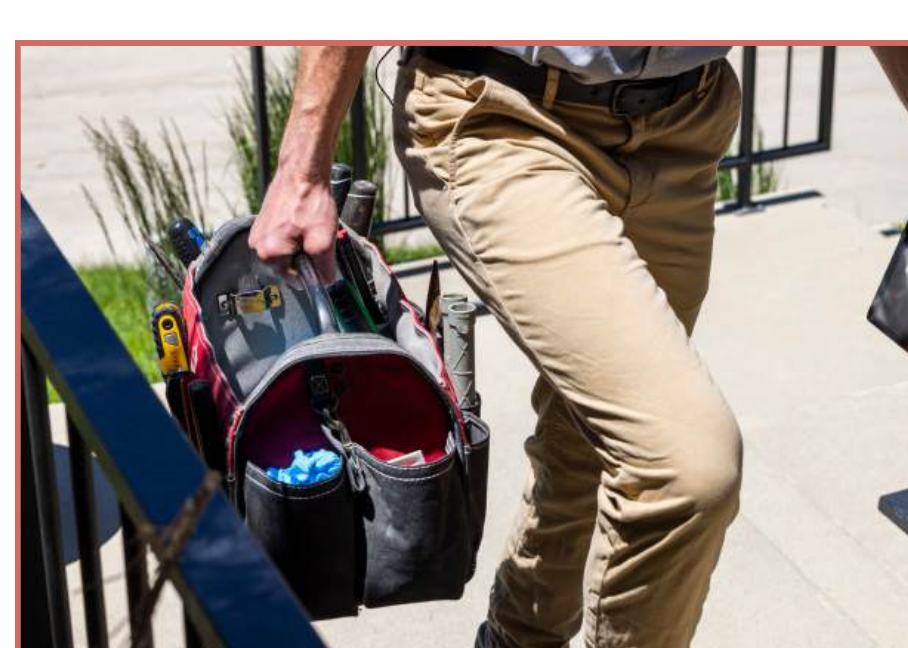
5. Arizona-Specific Licensing Considerations

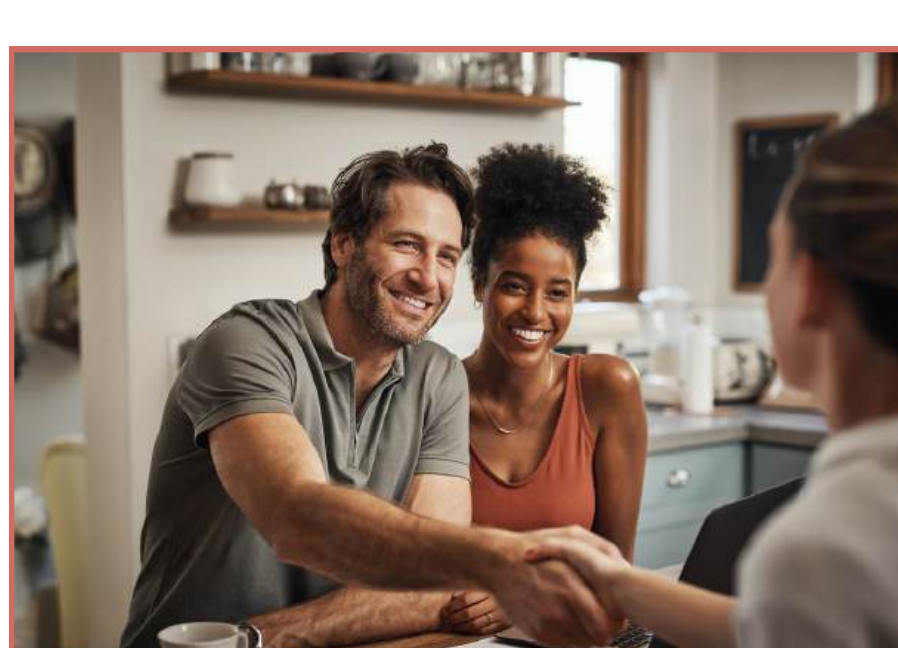
6. What to Ask Before Hiring a Handyman in Arizona
